#### 1 INTRODUCTION

You are on the page of the official website of the French Shooting Federation (FFTir), dedicated to the administrative organization of imports and exports of weapons and ammunition for the needs of the Paris 2024 Olympic Games.

The protection of your personal data is important to the French Shooting Federation (FFTir).

We are committed to collecting only the data we need to provide you with an optimal service, to ensure confidentiality and security, including when we use service providers, and to facilitate the exercise of your rights over your data.

Our first commitment is compliance with applicable data protection legislation.

The FFTir complies with the obligations resulting from the General Data Protection Regulation, known as the GDPR, and all national legislation implementing it in France, in particular the so-called "Informatique et Libertés" law of 6 January 1978 as amended.

Here we describe what we do with your data.

This privacy policy, which applies to all users of the services provided by the FFTir and its "FIREARM FILL FORM", hereinafter referred to as the Form, describes the personal data that is collected, its use and, where applicable, its sharing, and your rights.

It is intended to be clear, easily understandable and accessible at any time during your navigation.

We advise you to read it carefully.

If you would like clarification or if you have a question about this privacy policy, you can contact our data protection officer whose contact details are mentioned in paragraph 3.

#### Effective date:

The updated Privacy Policy is automatically effective for all active users as of January 24, 2024.

#### 2 THE DATA CONTROLLER

The data controller is the Fédération Française de Tir, an association under the law of 1901, registered under the SIRET number: 784 354 409 00046, whose registered office is located at 38, rue Brunel, 75017 PARIS.

#### 4 DATA WE PROCESS

As part of your use of our services and your browsing on our website, the FFTir processes several categories of data, the details of which you will find below.

#### This data comes from:

- Information that you voluntarily provide to us through the use of our online forms

- The informations collected are:
  - o Family Name, Given/Other Names
  - o Delegation
  - Mail adress
  - Adress
  - o Postal code / Zip code and town
  - Country
  - Passport number
  - Copy of the passport
  - Full identification of the weapon, or weapons imported and exported for the purposes of the Paris 2024 Olympic Games
  - Identification of imported and exported ammunition for the Paris 2024 Olympic Games
  - Makes, calibers and types of ammunition reserved

This data is mandatory and transmitted to the French Customs services for the management of administrative authorizations for the import/export of weapons and ammunition under the contract signed between the organizer of the Paris 2024 Olympic Games and the French Shooting Federation.

This processing is also based on the basis of the public interest mission, the French Shooting Federation being a delegated Federation within the meaning of the Sports Code.

We do not process sensitive data within the meaning of the GDPR (data that reveals racial or ethnic origin, political opinions, religious or philosophical beliefs or trade union membership, genetic data, biometric data, data concerning health or data concerning people's sex life or sexual orientation).

#### 5 COOKIES

#### What is a cookie?

A cookie is a file that we may save on the hard drive of your device (computer, tablet, smartphone, etc.) via your Internet browser when you use the site, subject to your consent or unless you object.

What is the purpose of the cookies issued on the site?

We use different types of cookies:

- Authentication cookies; Des cookies de sécurité et cookies relatifs à l'intégrité du site
- Location-based cookies
- Cookies related to the functionality of the site and services
- Analysis and research cookies and cookies to deliver advertising messages

You can accept, refuse or set your cookie choices when you first log in to our site and change your choices at any time by clicking on the quick settings tool located at the bottom right of the "Manage Consent" window.

In particular, we use "technical" cookies that are necessary for the proper functioning of the site. If you refuse the storage of cookies on your device, or if you delete those that are saved there, you will no longer be able to benefit from a certain number of features that are nevertheless necessary to browse certain areas of the site.

In this case, we decline all responsibility for the consequences related to the degraded functioning of the site resulting from the impossibility for us to save or consult the cookies necessary for their operation and that you have refused or deleted.

#### 6 LEGAL BASIS AND PURPOSES

The French Shooting Federation processes your personal data:

- Within the framework of the contract you have concluded between the French Shooting Federation and the Organising Committee of the Olympic Games, which has delegated the administrative procedures with the French Customs services
- To fulfil a mission of public interest (import and export of arms and ammunition on French territory)

We collect this data to enable us to provide the French Customs with all the information necessary for the examination of import/export authorizations for weapons and ammunition of competitors of the Paris 2024 Olympic Games.

## 7 RECIPIENT OR CATEGORY OF RECIPIENTS AND TRANSFER TO COUNTRIES OUTSIDE THE EUROPEAN UNION

The data collected through the "FIREARM FILL FORM" form is transmitted directly and only to the French Customs services.

The data collected through the "PARIS 2024 - SHOOTING COMPETITION - AMMUNITION ORDER FORM" form is only intended for the French Shooting Federation for the management of ammunition stocks during Olympic competitions.

Some of the services and features made available to you require us to share information with other entities. We may also share this information for legal reasons or in the event of a dispute.

We do not share your personal data with any other organisation or third party.

#### Between the entities of the FFTir:

The FFTir is likely to share information relating to athletes who have completed the forms for the proper management of its federal activities, and for the proper organization of Olympic competitions.

#### Important:

FFTir and its services do not resell your data and documents that you entrust to us to third parties and we do not disclose personal and private information outside of the situations described in this Privacy Policy.

#### 8 DATA RETENTION PERIOD

The retention periods for form data related to the Paris 2024 Olympic Games are strictly determined.

The data will be kept for up to one month after the end of the Paralympic Games. At the end of this period, they will be destroyed by means of secure systems.

#### 9 DATA SECURITY

We implement appropriate technical and organisational measures to guarantee the constant security, confidentiality, integrity, availability and resilience of our information system and your data and to protect the data, in particular personal data that we process, against the destruction, loss, alteration or unauthorised disclosure of transmitted data, stored or otherwise processed, or unauthorized access to, such data.

We are committed to implementing all available means to ensure the security and confidentiality of this data, in particular:

- We encrypt our services using SSL technology
- We conduct internal audits on data collection, storage and processing, including physical security measures, to prevent unauthorised access to our systems
- Access to personal data is strictly reserved for duly authorised FFTir staff. These individuals are subject to strict confidentiality obligations and may be subject to disciplinary action up to and including termination of employment if they fail to do so

#### 10 RIGHTS OF DATA SUBJECTS

In accordance with the GDPR and the provisions of the French law on the protection of personal data known as "Informatique et Libertés" of 6 January 1978, as amended, and the applicable national laws on the protection of personal data applicable in the States in which we operate, you have various rights as described below.

#### 10.1 Access rights

You have the right to access the data processed about you. It allows you to read the data we have about you and, if you wish, to request a copy of it, within the limits of compliance with the rights of third parties whose personal data may be included in the data concerning you.

#### 10.2 Rights to rectification

In accordance with the applicable regulations on the protection of personal data, you may request from us the rectification of personal data concerning you that is inaccurate. You can also request the completion of incomplete personal data concerning you, including by providing a supporting statement.

In order to make it as easy as possible for you to exercise this right, we invite you to make these changes and additions directly to your profile. If you feel that other data concerning you needs to be changed or supplemented and you are unable to make this change on your own, we invite you to make a request directly in the Your Rights section of our Data Protection Center or by writing to us at <u>J'exerce mes droits</u>

#### 10.3 Rights to erasure

You have the right to obtain from us the erasure of personal data concerning you without undue delay, subject to our legitimate interest or any legal obligation requiring us to retain it.

#### 10.4 Right to restriction of processing

You can ask the French Shooting Federation to limit the processing of your data (for example, temporarily making your profile unavailable on the site), when one of the following applies:

- You contest the accuracy of the personal data concerning you. In this case, we will hide your data for a period of time that allows us to verify its accuracy;
- You believe that the processing of your data is being carried out unlawfully and you object to its deletion and instead demand the restriction of its use;
- We no longer need your personal data for the purposes of the processing, but it is still necessary to enable you to establish, exercise or defend legal claims;
- You have exercised your right to object pursuant to Article 21(1) of the General Data Protection Regulation. We will restrict the processing of your data while we verify whether the legitimate grounds we pursue override your right.

If we decide to lift the restriction of the processing of your personal data, we will keep you informed.

#### 10.5 Right to object

You may also object, for legitimate reasons, to the processing of your data for which the French Shooting Federation has based itself on the public interest. It will then interrupt the processing unless there are legitimate and compelling reasons to justify the continuation of the processing (e.g. customs declarations, etc.) or for the establishment, exercise or defence of legal claims.

#### 10.8 The possibility of organising the fate of your personal data after your death

In France, the new article 40-1 of the Data Protection Act allows individuals to give directives relating to the retention, deletion and communication of their data after their death.

A person may be designated to carry out these directives. The latter is then entitled, when the person has died, to acquaint itself with the directives and request their implementation from the data controllers concerned.

These guidelines are:

• General, when they relate to all data concerning a person;

Particular, when they only concern certain specific data processing.

When these directives are general and relate to all of the deceased's data, they can be entrusted to a trusted third party certified by the CNIL.

In the case of specific directives, they can also be entrusted to data controllers (social networks, online messaging) in the event of death. They are subject to the specific consent of the data subject and cannot result solely from the latter's approval of the general terms and conditions of use.

In the absence of instructions given by the person during his or her lifetime, the heirs will be able to exercise certain rights, in particular:

- The right of access, if necessary for the settlement of the deceased's estate;
- The right to object to the closure of the deceased's user accounts and to object to the processing of their data.

#### 10.10 Right to lodge a complaint with a supervisory authority

Fftir.org is a website of the FFTir, which has its head office in PARIS. As such, the supervisory authority competent to hear any request concerning us, including, where applicable, a complaint from a user, is the Commission Nationale de l'Informatique et des Libertés (CNIL). However, you can refer the matter to any data protection authority, in particular in your country of residence, the country where you work, or in the country of which you are a national, and the latter will be responsible for forwarding your request to the CNIL.
